- 2024 Season Passes **paid in TOTAL** (season pass + cart option) by January 31, 2024, will become **Premier Passholders**. **Premier Passholders** will be entitled to the following: six (6) 9-Hole Guest Passes with Cart, an Unlimited Practice Range Pass, and a metal passholder card providing a 10% discount in the Golf Shop on all merchandise (except balls) and apparel, and 10% off the total bill in the Restaurant including alcohol. Passholders are required to play with their guests and guest passes are **not available for use on Saturdays**.
- 2024 Special Assessment: The BCCC Board of Directors is assessing \$20 per season pass to cover the Board liability insurance, attorney fees, supplies for the board election, and miscellaneous expenses.
- An additional 3% processing fee will be added to payments made by Credit Card.
- Children: Ages 12 and under play FREE with any Season Pass Purchase.
- College Student: Ages 19 -23 can purchase a College Student Season Pass OR they can be included in a Family Season Pass if they are living in the same household.
